

# Privacy Policies

## User Consent

By using The Rigging Shed Web System (this "Web System"), you signify your consent to this Web System's collection, use, and disclosure of your personal information in accordance with this policy.

## General Information Collection

### *Non-Identifiable Information*

Like many other Web sites, this Web System automatically collects certain non-identifiable information regarding this Web System users, such as the Internet Protocol (IP) address of your computer, the IP address of your Internet Service Provider, the date and time you access this Web System, the Internet browser you are using, the sections of this Web System you visit, and the content you download or email from this Web System. This non-identifiable information is used for this Web System and system administration purposes and to improve this Web System. The Rigging Shed may also use non-identifiable information to initiate interactive, real-time discussions with users. Your non-identifiable information may be disclosed to others and permanently archived for future use.

### *Cookies*

This Web System uses "cookies", a technology that installs a small amount of information on this Web System user's computer to permit this Web System to recognize user preferences and future visits using that computer. Cookies enhance the convenience and use of This Web System. For example, the information provided through cookies is used to recognize you as a previous user of this Web System (so you do not have to enter your personal information every time), offer personalized web page content and information for your use, track your activity at this Web System to respond to your needs, and otherwise facilitate your web experience. You may choose to decline cookies if your browser permits, but doing so may affect your use of this Web System and your ability to access certain features of this Web System.

### *Tracking Information*

The Rigging Shed may use non-personal information to create aggregate tracking information reports regarding these Web System user demographics and web traffic patterns, and then provide those reports to The Rigging Shed. None of the tracking information in the reports can be connected to the identities or other personal information of individual users. The Rigging Shed also may link tracking information with personal information voluntarily provided by these Web System users. Once such a link is made, all of the linked information is treated as personal information and will be used and disclosed only in accordance with this policy.

## Personal Information Provided By User

### *Your Personal Information*

During your use of this Web System, you may be asked to voluntarily provide certain personal information (such as your name, email address, telephone number, or postal address) for purposes such as facilitating communications with you, applying for access to certain special features of this Web System. ### *Use of Your Personal Information*

From time to time The Rigging Shed may also send to you email containing important information regarding This Web System, which you may not opt out of receiving.

### *Disclosure of Your Personal Information*

The Rigging Shed may disclose your personal information in the following circumstance:

Law Enforcement and Legal Disclosure - The Rigging Shed may disclose your personal information to a government institution that has asserted its lawful authority to obtain the information or where The Rigging Shed has reasonable grounds to believe the information could be useful in the investigation of unlawful activity, or to comply with a subpoena or warrant or an order made by a court, person or body with jurisdiction to compel the production of information, or to comply with court rules regarding the production of records and information, or to The Rigging Shed's legal counsel.

### *Securing Your Information*

To help protect the confidentiality of your personal information, The Rigging Shed employs security safeguards appropriate to the sensitivity of the information. Nevertheless, due to the nature of the Internet and Internet technologies, security and privacy risks cannot be eliminated and The Rigging Shed cannot guarantee that your personal information will not be disclosed in ways not otherwise described in this policy.
